Miscellaneous: approximately \$450.00 was made on the corn hole tournament which was donated to the Lions Club and the Fire Department. Suggestions for a possible bigger and better sign directing people to the Lions Club Field. Approximately 450 chicken halves were sold.

Diane Rice addressed the board about buying a speed sign to slow cars down on Main Street.

Joyce Gagnon complained about the condition of County Route 23 and the River Road.
